This is in relation to Financial Management Guidelines No. 27 series of 2020 dated 23 October 2020, with deadline of submission of financial claims: Obligation Request and Status (ORS) and Disbursement Voucher (DV) for CY 2020 on December 29, 2020.

We would like to remind and emphasize the following:

 Validity of the 4th quarter Notice of Cash Allocation (NCA) shall be until the last working day of the 3rd month of the quarter¹, in this case, on December 29, 2020, hence, to maximize the cash utilization of the Department and to give ample time for the processing of payment through List and Due and Demandable Accounts Payable – Advice to Debit Account (LDDAP-ADA), may we request the OBSUs to forward all duly approved DVs to FMS Cash Division on or before December 23, 2020.

All LDDAP-ADAs submitted to Land Bank of the Philippines (LBP) on or before December 28, 2020 will be credited to the claimant's respective LBP bank accounts on or before December 29, 2020². While LDDAP-ADAs submitted to LBP on December 29, 2020 may be credited on the 1st banking day of CY 2021.

2. Claims already obligated with approved payment validated by LBP until December 29, 2020 are considered paid, while, claims already obligated without approved/processed payment on December 29, 2020 will be part

3. Any ORS submitted beyond the deadline of December 29, 2020 will not be included as obligations of CY 2020 and may be considered as unbooked obligations which may be filed personally by the claimant directly to the Commission on Audit (COA).
